As per the provision in section 2(e) and section 10(4) of Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (Mah. XXVIII of 2015), the Competent Authority is conducting CET (**MAH-MCA-CET 2018**) for admission to MCA courses.

The Online applications are invited for CET for admission to First Year / Direct Second Year (Separate Division & Lateral Entry) of Three-year full time Post Graduate Degree course in Master of Computer Applications (MCA) in the Government, Govt. Aided, University Managed, University Departments and Unaided Institutes in the Maharashtra State.

Instructions for Registration for MAH-MCA-CET 2018:

- Aspiring candidates can download CET Information brochure from website <http://www.dtemaharashtra.gov.in/mcacet2018> for details.
- It is mandatory for all aspiring candidates to **Register & Confirm** the Online Application Form through candidate login by himself/herself on website.
- The Online CET would be comprised of four sections viz. Mathematics and Statistics, Logical/Abstract Reasoning, English Comprehension and Computer Concepts of 200 marks, with composite time of 90 minutes' duration.
- Note that the CET will have negative mark system. Each correct answer will carry 2 marks. Each wrong answer will carry 0.5 negative mark. Unanswered questions will carry zero marks.
- It should be noted that no documents are required to be submitted at the stage of registration for CET. However, Candidates are advised to keep the necessary original documents ready for verification at the time of Document verification stage, during Centralized Admission Process (CAP).
- Applications sent by Post/Courier etc., will be rejected and no communication in this regard will be made.
- MAH-MCA-CET 2018 shall be conducted only in the ONLINE mode in multiple sessions if required by Competent Authority, using standardized equi-percentile method, will be equating scores across sessions.
- Aspiring candidates should note that, the tests are not disclosed to anybody else other than the candidates only during the examination. The test papers are also not shared with anybody even after the examination.
- The schedule displayed above is provisional and may change under unavoidable circumstances. The revised schedule, if any, will be notified on website.
